Sir/Madam,

This is with reference to school application No.-IS-04006-2425 dt. on the subject cited above.

Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 38 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 6 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

Sl. No.	CONDITIONS FOR COMPLIANCE
1	School has uploaded land certificate dated 29.06.2013 having land area 6710 sq mts (for which school wants 38 sections from Class I to XII), however, as per SARAS 4.0 Circular no.16/2023 dated 28.04.2023 land certificate should be issued not more than 01 year before the date of application; therefore, school is required to upload land certificate issued by DM/ ADM/ SDM/ Tehsildar/ Naib Tehsildar/ Registrar/ Sub Registrar/ Equivalent Land Authority STRICTLY as per Appendix-X of Circular no.12/2022 dated 14.10.2022 clearly depicting the details of actual owner of land and who further lease the land to school or Society/Trust running the school.
2	School has uploaded document dated 05.02.2023 against Building Safety Certificate which is not as per Appendix-XI and also the validity of the same cannot be ascertained; therefore, school is required to upload the building safety certificate with validity period issued by Assistant Engineer and above rank officer of Govt. Department as per Appendix-XI of Circular no.12/2022 dated 14.10.2022 clearly depicting the details of number of blocks and number of floors in each block running in the school.
3	School shall ensure renewal of other essential certificates time to time and upload them on school's website under the "Mandatory Public Disclosure" icon in compliance of Circular no.09/2021 dated 21.05.2021.
4	School shall ensure size of all class rooms (sections) running should be as per Board norms i.e. each class room should be of size 500 sq ft.
5	School shall ensure section teacher ratio of 1:1.5 excluding principal, physical education teacher and counsellor, to teach various subjects and appoint qualified trained teaching staff on regular basis as per the provisions laid down in Affiliation Bye-Laws, 2018.
6	School is advised to go through the SARAS 4.0 Manual before uploading the compliance. Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs.50,000/- every month until compliance is submitted.
